Bit by bit, the Ocean State is renewing its commitment to Rhode Islanders with disabilities. Recent improvements, advocacy victories, and policy advancements are paving the way for better access to healthcare, employment opportunities, financial stability, and independent living.

Simplifying the Voting Process

Over the summer, the Governor's Commission on Disabilities advocated on behalf of the disabled community to enable the mail ballot application form with electronic signature capability. This allowed individuals with vision and motor disabilities to participate in elections without the barrier of traditional paper forms.

Establishing the Olmstead Commission

Governor Dan McKee recently issued an executive order to establish the Olmstead Commission, ensuring that the state progresses with its legislated task of creating an Olmstead Plan to protect and advance independent living opportunities in Rhode Island.

Enhancing Employment Opportunities

Rhode Island launched the Ticket to Work program on September 20 to support working people with disabilities. While the Sherlock Plan allowed Medicaid "buy-in," it imposed limits on income and assets, restricting savings and career growth. The new program, passed after a large advocacy effort in 2023, removes these limits for workers with disabilities under 65.

You can help ensure accessible voting in Rhode Island!

For every election, the GCD recruits volunteers to survey voter polling placess and ensure that all polling places are free of barriers that would prevent someone with a disability from voting. They are now recruiting volunteers for the General Election on November 5, 2024. Each survey takes about fifteen minutes and can be completed at any time during Election Day. Volunteers can use our online survey or a print version.

There were 345 polling places open for the State Primary Election on September 10, 2024, for which the GCD recruited 28 volunteers who covered 206 polling places. For the General Election on November 5, 2024, there are 455 Voter Polling Places open, so they need more volunteers.

6 Our goal is to double our number of volunteers to cover the entire state on November 5th.

The data that volunteers provide enables the GCD to work with local Boards of Canvassers to remove barriers to voting on the day of the election and in future elections.


